Arrête :

**Art. 2.** – La période de dépôt des candidatures à la fonction de conseiller prud'homme, par les organisations syndicales et professionnelles mentionnées en annexe de l'article 1<sup>er</sup>, est fixée du mercredi 22 janvier 2020 à 12 heures au lundi 17 février 2020 à 12 heures.

**Art. 3.** – Le directeur des services judiciaire est chargé de l'exécution du présent arrêté, qui sera publié au *Journal officiel* de la République française.
